"The Cyprus Crisis: A Declassified Dossier" Presented in Greece, Cyprus

Graduate Research Fellow Gregory Graves presented "The Cyprus Crisis: A Declassified Dossier," addressing the significance of

the 4,000 documents he discovered relating to the invasion of Cyprus, to members of the Cypriot House of Representatives, in a closed session setting, March 13th. Graves presented his research findings at the invitation of House of Representatives President Demetris Syllouris, who also honored AHI for its work to raise awareness of the declassified dossier. negative imagery or fear tactics.

AHI Responds to Correct the Record on Greek American Lobby's Effectiveness

Kathimerini, a daily newspaper published in Athens, Greece, published the American Hellenic Institute's (AHI) <u>response</u> to a December 20, 2017 commentary titled, "<u>Hellenism in America at a crossroads</u>" by Editor Alexis Papachelas, in its electronic edition, Ekathimerini, on January 1, 2018. A condensed version of AHI's response was published in Kathimerini's English print edition, which is inserted as a supplement to the international edition of the New York Times in Greece and Cyprus, on January 5, 2018.

In his letter, AHI President Nick Larigakis states Mr. Papahelas' assessment of the Greek American lobby's role, especially regarding Greece's strategic importance, is flawed and it demonstrates a lack of understanding of what transpires in Washington. Larigakis cites AHI-hosted panel discussions and presentations featuring Greece's top military officials in Washington in addition to AHI collaborations with prominent Washington, D.C. think tanks on the release of white papers detailing Greece's strategic importance, as recent examples of successful initiatives to raise awareness about the topic. Larigakis also presents examples of public policy initiatives and testimonials from U.S. government officials attesting to AHI's efforts and effectiveness in Washington.

AHI Conducts Annual Trip to Greece, Cyprus

An American Hellenic Institute delegation successfully completed the organization's annual leadership trip to Greece and Cyprus where it held substantive meetings with high-ranking government officials with the purpose of strengthening relations and addressing issues of mutual interest. The six-day trip occurred May 13 to 18, 2018.

"We had a very productive series of high-visibility meetings in Greece and Cyprus," President Nick Larigakis said. "We accomplished the objectives we set out to achieve, and the briefings we received on issues of importance to the Greek American community were insightful and informative. We thank all of the leaders who took the time to meet with us to discuss these very important issues."

Cyprus

The AHI delegation received multiple briefings from Cypriot and American officials on the Cyprus problem; Cyprus' efforts to explore for hydrocarbon reserves in its exclusive economic zone (EEZ), and on Cypriot commerce and tourism sectors. In addition, there were discussions about raising awareness in the United States of the Missing Cypriots issue. All throughout the delegation's meetings in Cyprus, AHI was commended for its past advocacy and

current steadfast efforts to keep the Cyprus issue highly visible with key policymakers in the Obama administration and in the U.S. Congress.

During its stay in Cyprus, May 13 to 15, the delegation met with: U.S. Ambassador to the Republic of Cyprus Kathleen Doherty, Minister of Foreign Affairs Nikos Christodoulides, Minister of Defense Savvas Angelides, President of the House of Representatives Demetris Syllouris, Ambassador Andreas Mavroyiannis, the chief negotiator for settlement talks; Fotis Fotiou, commissioner to the Presidency for Humanitarian Affairs and Overseas Cypriots; His Beatitude Archbishop

Chrysostomos II, Dr. Stelios Nicolaides, director, Hydrocarbons Service, Ministry of Energy, Commerce, Industry, and Tourism; and Lt. General Ili-

as Leontaris, chief of the National Guard General Staff, who also hosted a dinner for the delegation at the Officers Club.

"Our meetings provided us with an update on the prospects for restarting the settlement talks," Larigakis said. "Of course, Turkey must abandon its demand to retain its guarantor power, remove its 40,000 illegally-staged troops, and cease its provocations, if a just and viable solution for all Cypriots is to be reached."

Greece

The AHI delegation visited Athens May 16 to 18, 2018. In addition to briefings with ministry officials, the itinerary included the 14th Annual AHI Athens Hellenic Heritage Achievement and Public Service Awards Dinner at the Grand Bretagne Hotel, May 18 (see news release).

"Our meetings covered a broad range of issue topics under the scope of the bilateral relationship between the United States and Greece in addition to Greece's role in the region," Larigakis said. "We also explored ways in which the

AHI hosted a panel presentation featuring Greece's Minister of Digital Policy, Telecommunications and Information Nikos Pappas and Deputy Assistant Secretary of State for the Bureau of European & Eurasian Affairs Jonathan Cohen, February 9, 2018, at the Capital Hilton, Washington, D.C. The panelists spoke about their five-day, five-city U.S. tour in support of the 2018 Thessaloniki International Fair.

The United States will be the honored country at the Fair, which will be held September 8-16, 2018. The Fair's theme is "Harnessing the Power of Innovation and Creativity."

Minister Pappas reviewed their U.S. tour to five cities, which included visits to companies such as: Facebook, Lockheed Martin, Netflix, AirBnb, and Electronic Arts, among others, to recruit investors and exhibitors for the Thessaloniki International Fair. He touted Greece's incentive

plan to attract companies in the audio/visual and film sector.

Deputy Assistant Secretary Cohen stated the Thessaloniki International Fair will be the most important event in U.S.-Greece relations in 2018, adding that Secretary of Commerce Wilbur Ross will attend. He reflected on his experience at Capital Link Forum in New York City in December as an indication the investment community and Wall Street is bullish about Greece's future.

AHI Panel Examines U.S. Strategic Interests in Aegean Sea, Cyprus

(AHI) hosted a panel discussion on the topic, "U.S. Strategic Interests: The Aegean Sea & Cyprus' EEZ," April 17, 2018, at the Capital Hilton, Washington, D.C. The panelists included: Cato Institute Senior Fellow Doug Bandow, AHI Legal Counsel and Partner at Sfikas & Karambelas Nick Karambelas, and Trilogy Advisors LLC Principal John Sitilides. AHI President Nick Larigakis moderated the panel discussion, which was followed by a Q&A session with the audience.

AHI President Larigakis opened the panel discussion with welcome remarks. He provided the backdrop of the current state of events in the eastern Mediterranean and why it is in the best interests of the United States for the region to be politically, economically, and socially stable and peaceful.

AHI Legal Counsel Karambelas presented on the rule of law of how it applies to the Aegean Sea and to the exclusive economic zone (EEZ) of Cyprus. With regard to the Aegean Sea, the United States was not a signatory to the Treaty of Lausanne, which ceded the Dodecanese islands and islets to Italy from the Ottoman Empire, because the United States did not declare war on the Ottoman Empire. However, under the Treaty of Paris of 1947, to which the United States is a party, the Dodecanese Islands and adjacent islets as well as Kastelorizo along with its adjacent islets were ceded by Italy to Greece. The Treaty of Paris is U.S. federal law and the U.S. is bound to enforce it. Karambelas raised the question as to the role of the president in enforcing treaties to which the U.S. is a party. He added that Congress has the implied power to order the president to comply with such treaties.

Further, Karambelas offered a concept in international

law known as "persistent objector" as a legal explanation as to why Turkey constantly violates Greece's sovereignty in the Aegean. Karambelas stated that President Erdogan has taken a tact which is different from previous Turkish leaders. They questioned the interpretation of the treaty. President Erdogan maintains that the treaty itself is unlawful and must be discarded.

Finally, Karambelas stated that only one treaty applies to the Exclusive Economic Zone (EEZ) of Cyprus, the UN Law of the Sea Convention (UNCLOS). Turkey is not a signatory. He explained how the maritime borders and the EEZ's are delineated under UNCLOS. Karambelas dismissed any Turkish claims that islands do not have an EEZ or continental shelf because under UNCLOS they clearly do. He also dismissed Turkey's claims that its continental shelf extends into the Cyprus EEZ because Turkish-occupied Cyprus is not a nation-state. It has none of the maritime zones to which a nation-state is entitled. Because islands have EEZs, Kastelorizo which is south of the Turkish mainland has an EEZ which connects to Greek EEZ with the Cypriot EEZ. Turkey asserts that islands do not have EEZs so that the Turkish EEZ to the south of the Turkish mainland and cuts off this connection.

John Sitilides, Principal at Trilogy Advisors and a diplomacy consultant to the State Department, addressed the geostrategic implications of the U.S.-Greece relationship, opening with the role Greece played in April's coalition missile strikes in Syria. Sitilides described an "arc of crisis" ranging from Russia' occupation of Ukraine, Turkey's attacks on Syrian Kurds allied with the U.S. and its ongoing occupation of Syria, Iraq and Cyprus; Islamic State's spread into the Sinai Peninsula, near the critical Suez Canal chokepoint; and the anarchic battlefields of Libya, through which massive numbers of African migrants are crossing into and overwhelming southern Europe.

"Greece is at the heart of these significant geopolitical risk issues throughout the eastern Mediterranean, southeastern Europe and the Middle East for the United States," he said.

Sitilides spoke about the strategic importance of the Aegean Sea to the modern Greek nation-state and detailed the series of Turkey's challenges to Greece's Aegean sovereignty rights since 1973. Greece-Turkey tensions are the larger problem from the United States' perspective, he stated, emphasizing the importance to Washington of very close relations with both Athens and Ankara. Historically, Washington has sought to play the role of honest broker to foster an environment for Greece and Turkey to mutually resolve their differences. However, Sitilides noted that NATO Secretary General Jens Stoltenberg has downplayed the most recent Turkish provocations against Greece, including Turkish threats to invade Greek islands, and noted that NATO has no provision to resolve intra-alliance conflict that could occur between allies Greece and Turkey. Sitilides stated that NATO has an absolute obligation to intercede and dissuade Turkey from any further threats against a fellow NATO member. Further, Sitilides conveyed concern about Turkey's recent ramping-up of Aegean sovereignty challenges and noted Turkey's diplomatic leverage: two Greek soldiers in custody and three million Syrian refugees in Turkey which Ankara can send towards the Aegean. Sitilides predicted early Turkish elections would be held in summer 2018, rather than summer 2019, and that efforts to maximize Turkish nationalist voter turnout would likely lead to escalated Turkey's threats against Greece in the intervening period, and potentially beyond the elections.

Cato Institute Senior Fellow Bandow debunked the notion of Turkey serving as a vital U.S. ally. He noted Turkey's refusal to grant the United States the ability to open a northern front against Saddam Hussein in 2003, Turkey's role in giving rise to ISIS, President Erdogan's threat to U.S. military personnel in Manbij, Syria, Turkey's purchase of Russian S-400 missiles and their interoperability with NATO, and Turkey using refugees as a weapon to disrupt Europe. Bandow asserted Turkey is not a bridge to Europe and that the notion of Turkey becoming an EU member is "fantasy," adding it would require a change of culture and political leadership.

He encouraged the community to reach out to their members of Congress to advocate on these issues.

AHI Submits Testimony to House Appropriators on FY2019 Foreign Aid to Eastern Mediterranean

AHI submitted testimony to the House of Representatives Appropriations Subcommittee on State, Foreign Operations, and Related Programs on the Trump Administration's foreign aid proposal for FY2019 on April 20, 2018.

In the best interests of the United States, AHI's testimony opposed: (1) any military assistance the administration will request for Turkey until: Turkey withdraws all of its troops and illegal Turkish settlers in Cyprus and Turkey ceases and desists its acts of provocation and aggression in the Aegean; (2) a reorganization of the Overseas Private Investment Corporation (OPIC) that would prevent its authorization from doing business in Greece—a policy shift achieved in 2016 due to Greece's economic crisis; (3) aid the administration will request for the Former Yugoslav Republic of Macedonia (FYROM) until a mutually-agreeable solution to the name-recognition issue is achieved; and (4) any reduction that might be introduced in the aid levels for the UN Peacekeeping Force in Cyprus.

Also, in keeping with the best interests of the United States, AHI applauded the FY2018 enacted level of funding of \$1 million for NATO ally Greece's International Military Education and Training (IMET) program and supported a recommended appropriation of \$1.2 million for FY2019.

In addition, AHI's testimony recommended that appropriations language be included in the bill that addressed how United States foreign assistance can help solidify a reunified Cyprus and its government in the event of reunification.

than 20 high-ranking government and military officials—in addition to policy analysts and community leaders—from the three countries and the United States. AHI Urges President Trump to Condemn Turkish Aggression

AHI sent a letter to President Donald J. Trump in the wake of acts of Turkish provocation and aggression in the eastern Mediterranean and broader region that have dire implications to U.S. security interests.

In the February 27, 2018 letter, AHI President Nick Larigakis requests President Trump to condemn strongly Turkish aggression and acts of provocations that have been directed at the United States, Greece, Cyprus, and international oil and gas companies—all of which have occurred in the month of February. Larigakis cites: a Turkish coastguard vessel colliding with a stationary Greek coastguard vessel, the harassment of Italian oil company Eni's surveying vessel by Turkish warships, which threatened to sink Eni's surveying vessel because it was on its way to survey for energy resources in the exclusive economic zone of Cyprus; and Turkish President Erdogan's threat of an "Ottoman slap" to United States military forces if they continued to partner with Syrian Kurds in Syria. In addition, Larigakis raised the concern among NATO allies about Turkey's purchase of four divisions of S-400 missiles from Russia and how it potentially subjects Turkey to U.S. sanctions.

Congressman Bilirakis Submits AHI Letter into Congressional Record

U.S. Representative Gus M. Bilirakis (R-FL), cochair, Congressional Caucus on Hellenic Issues, and co-chair, Congressional Hellenic Israeli Alliance, submitted into the Congressional Record, American Hellenic Institute's (AHI) February 27, 2018 letter to President Donald J. Trump that urged the U.S. government to condemn strongly recent acts of Turkish provocation and aggression in the eastern Mediterranean and the broader region, which present dire consequences to U.S. security interests.

In his March 13, 2018 Extension of Remarks,



Congressman Bilirakis stated: "Mr. Speaker, I include in the Record a letter from the American Hellenic Institute regarding Turkey's continued dangerous actions in the eastern Mediterranean and broader region that threaten regional security and U.S. interests. As one of the co-chairs of the Congressional Hellenic Caucus, I have advocated for the rights of Greece and Cyprus against the intimidating actions of Turkey. Since Turkey's Presidential referendum vote, Erdogan's government continues to ignore and violate long-standing international law and treaties—a threat to regional security and an impediment to regional interests, stability, and prosperity."

In addition, as he has done previously, Congressman Bilirakis stated the United States, and its regional allies, should be better prepared to respond with targeted sanctions and foreign aid restrictions for any nation that transgresses international law, including NATO ally Turkey.

AHI President Nick Larigakis stated, "We applaud Congressman Bilirakis for his staunch advocacy of Greece and Cyprus and for calling out Turkey as a threat to regional security and condemning Turkish aggression. We sincerely thank the congressman for entering our letter into the Congressional Record and his support."

AHI Urges NATO Secretary General to Address Turkey's Behavior

AHI sent a letter to NATO Secretary General Jens Stoltenberg to convey strong concern regarding the actions and behavior of NATO member Turkey toward fellow Alliance member countries. AHI also expressed profound disappointment with NATO's inability to address intra-Alliance conflicts because it lacks a provision or mechanism to deal with such an issue.

In the May 8 letter, AHI President Nick Larigakis contends Turkey continues to demonstrate it is not a true and dependable NATO ally. Larigakis cited numerous examples, including: Turkish threats directed at the United States military in Manbij, Syria, Turkey's purchase of Russian S-400 missiles, Turkey's countless violations of Greece's sovereignty in the Aegean, and Turkish aggression toward the surveying vessel of a multinational oil company (Eni) headquartered in NATO-member Italy that was preparing to survey in the exclusive economic zone of Cyprus.

"Clearly, Turkey does not share NATO's core purpose or best interests. Numerous foreign policy and defense policy analysts and journals have called into question Turkey's actions as a NATO ally. It is unbecoming of a NATO member to act in the aggressive and provocative manner as it has toward fellow Alliance-member countries, United States and Greece. We believe it is time for NATO to explore how to ease tensions and address Turkey's intra-Alliance unproductive behavior," Larigakis concludes.

AHI Applauds Boost to Greece's IMET Program for FY2018

AHI applauded the enactment of the FY2018 Omnibus appropriations bill that was signed into law, March 23, 2018.

"The fiscal year 2018 appropriations bill will bolster relations between the United States and Greece, especially in defense cooperation," AHI President Nick Larigakis said.

AHI worked with Congress to secure a much-needed boost for Greece's International Military Education and Training Program, after the Administration submitted an FY2018 budget request of \$150,000. AHI recommended an increase in the investment to Greece's IMET program to House and Senate appropriators in written testimony AHI President Larigakis submitted in March and June 2017. AHI worked with Senator Chris Van Hollen (D-MD), a member of the Senate Appropriations Subcommittee on State, Foreign Operations, and Related Programs; to secure an initial appropriation of \$425,000 in the U.S. Senate's FY2018 Department of State, Foreign Operations, and Related Programs Appropriations Bill, in September 2017.

Separately, Senator Lindsey Graham (R-SC), who chairs the Senate Appropriations Subcommittee on State, Foreign Operations, and Related Programs, visited with Greek and U.S. government officials in Washington and Athens, to gain firsthand knowledge about defense cooperation between NATO allies Greece and United States.

"As chairman of the Appropriations Subcommittee, Senator Graham was instrumental in the final appropriation of \$1 million for Greece's IMET program," Larigakis said. "We thank Congress, especially Senators Graham and Van Hollen, appropriators whose lead helped to secure this funding for Greece's IMET program. It will bolster the number of Hellenic officers who are able to receive training in the United States to the benefit of relations between longtime NATO allies, United States and Greece."

Report Language Included on Greece's F-16 Upgrade Request

Also, AHI welcomes report language that accompanies the legislation that also requires the Secretary of State and Secretary of Defense to submit a report to Congress recommending how Foreign Military Financing can be used to support Greece's purchase of F-16 upgrades.

"As U.S. Ambassador to Greece Geoffrey Pyatt has described in recent interviews, Greece's role as 'a regional pillar of stability,' and 'a builder of bridges,' especially in defense cooperation, has been evident," Larigakis said. "The fiscal year 2018 spending bill sends a strong message that the United States appreciates its alliance with Greece."

AHI Supports Legislation to Limit Transfer of F-35s to Turkey

AHI supported the introduction of legislation aimed to limit the transfer of F-35 fighter jets to Turkey and commends the bill's three original sponsors, U.S. Senators

James Lankford (R-OK), Jeanne Shaheen (D-NH), and Tom Tillis (R-NC).

"We thank the bill's sponsor, Senator Lankford, and the bill's original co-sponsors, Senators Shaheen and Tillis," AHI President Nick Larigakis said. "The transfer of such sensitive technology to the Erdogan regime, which has purchased the S-400 missile system from Russia despite U.S. and NATO objections, is a threat to U.S. interests and security. We urge Congress to pass this legislation."

Larigakis sent letters to each of the three senators thanking them and conveying AHI's strong support for the legislation, S.2781. The letters outlined several reasons for AHI's backing of the legislation, including Turkey's blatant disregard for the rule of law as it pertains toward Greece, Cyprus, and the Ecumenical Patriarchate. In addition, Larigakis cited the Turkish government's threats toward the United States military and Turkish nationals working for the U.S. Embassy and the wrongful imprisonment of Pastor Andrew Brunson.

Subsequent Congressional Action Welcomed

In a May 29, 2018 announcement, AHI welcomed further congressional action in a response to Turkey's behavior, which has not met the principles and standards of a NATO member nation, via the National Defense Authorization Act of 2019 (NDAA). NDAA is legislation Congress passes each year that sets policy and funding levels for the Department of Defense. This year, the legislation in the U.S. House of Representatives and the U.S. Senate each contains provisions that aim at Turkey's participation in the F-35 program.

As we have stated all along, Turkey does not share NATO's core purpose or best interests," AHI President Nick Larigakis said. "It is unbecoming of a NATO member to act in the aggressive and provocative manner as it has toward fellow Alliance-member countries. It is time to hold Turkey accountable, and we are encouraged Congress is taking measures to do so."

He added, ""We thank Senators Thom Tillis and Jeanne Shaheen, who are members of the Senate Armed Services Committee, for their initiative and hard work to secure their amendment that targets Turkey's participation in the F-35 program," Larigakis said. "We also thank the House Armed Services Committee for drafting and advancing a bill with a strong provision that passed the U.S. House of Representatives."

In the announcement, AHI provided its audience with a thorough analysis of where the legislation stood in the House of Representatives and Senate at the time.

AHI Statement on Turkish aggression in Cyprus' Exclusive Economic Zone

AHI issued a February 13, 2018 statement on Turkish aggression in Cyprus' exclusive economic zone (EEZ):

waters to start exploring for gas is the latest in a recent string of Turkish aggression in the eastern Mediterranean, which AHI strongly condemns. In recent years, Turkey has violated international law by practicing "gunboat diplomacy" in the eastern Mediterranean with incursions into Cyprus' exclusive economic zone. To further illustrate Turkey's history of provocation, Turkey issued a Navtex in April 2017, stating its coverage not only included Cyprus' EEZ, but it also extended into a part of Cyprus' territorial waters. Adding to these examples is Turkey's intensified military presence in an area stretching south from Rhodes to the coast of Paphos in Cyprus and the issuance of three consecutive Notices to Airmen (NOTAM) for military exercises over Turkish-occupied northern Cyprus.

The Republic of Cyprus has the sovereign right under international law to explore and exploit its natural resources within its exclusive economic zone. The United States has stated repeatedly it supports Cyprus' sovereign right to explore energy in its offshore areas. In addition, Turkish aggression in Cyprus' EEZ presents an endangerment to U.S. companies, such as ExxonMobil and Noble Energy, who have been, or will be, working to explore for hydrocarbons in the eastern Mediterranean.

Egypt and the European Union have rebuked Turkey's most recent action to block ENI's rig from reaching Cypriot waters. Today, Turkish President Erdogan threatened that Cyprus, Greece, and the companies, which are in the process of exploring for energy resources, should not "step out of line" and that Cyprus' strength will only last until "they see our ships and our planes." Therefore, we call on President Donald Trump to condemn, in the strongest terms, Turkey for its series of aggressive actions that have occurred in the island's exclusive economic zone during the past year, and its president, Recep Tayyip Erdogan, for his bellicose rhetoric to Cyprus, Greece, and international companies.

Emirates Airline Report Noting "Healthy Demand" on Newark-Athens Service Welcomed

AHI welcomed Emirates Airline's announcement that marked the one-year anniversary of its Newark service via Athens, Greece, calling the first year a success.

According to Emirates, the airline reported "healthy demand" from Greek American communities and leisure

travelers with over 160,000 passengers carried on the only year-round service between New York and Athens. In addition, Emirates noted the service helped increase the number of passengers on the route by 50% during the summer months between April and August 2017, a statistic reported by the U.S. Department of Transportation.

"We welcome Emirates Airline's report and congratulate the airline for a banner first year, providing an invaluable service to the marketplace," AHI President Nick Larigakis said. "The report confirms our position, which has been that a direct, year-round service between a United States hub and Athens is warranted. It is not a surprise that a direct flight between two of the world's premier destinations, New York and Athens, would yield 'healthy demand."
